

Ordinance No. 182666
An ordinance dedicating, accepting and establishing certain real property owned by the City of Los Angeles as part of the west side of Victory Boulevard west of Balboa Boulevard, all public streets of said City.

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. The City Council of the City of Los Angeles finds that the public interest, convenience and necessity require that an easement for public street purposes over the following described real property owned by the City be, and same is hereby dedicated, accepted and established as part of Victory Boulevard, all public streets of said City.

No. 4180, IN THE CITY OF LOS ANGELES, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, AS PER MAP FILED IN BOOK 128, PAGES 50 AND 51 OF PARCEL MAPS, IN THE OFFICE OF THE COUNTY RECORDER OF SAID COUNTY; THENCE NORTHERLY ALONG THE NORTHERLY PROLONGATION OF THE WESTERLY LINE OF SAID PARCEL A TO THE SOUTHERLY LINE OF VICTORY BOULEVARD 100.00 FEET WIDE AS SHOWN ON SAID PARCEL MAP; THENCE WESTERLY ALONG SAID SOUTHERLY LINE OF VICTORY BOULEVARD A DISTANT OF 322.20 FEET TO THE NORTHERLY PROLONGATION OF THE WESTERLY LINE OF PARCEL B OF SAID PARCEL MAP; THENCE SOUTHERLY ALONG LAST SAID WESTERLY LINE TO THE NORTHERLY LINE OF SAID PARCEL B; THENCE EASTERLY ALONG LAST SAID NORTHERLY LINE TO THE POINT OF BEGINNING.

Section 2. Pursuant to the provisions of Section 252 of the Charter of the City of Los Angeles, this ordinance shall become effective upon publication.
